1 INTRODUCTION

1.1 Background

1.1.1 The Andhra Pradesh Airports Development Corporation Limited (“Authority”) is the statutory body entrusted with the development, operation and management of airports in the state of Andhra Pradesh. The Authority has initiated the expansion of its brownfield airport **Uyyalawada Narasimha Reddy Airport at Kurnool in Andhra Pradesh (“Project”)** under the Public-Private Partnership (PPP) framework, marking the first brownfield PPP airport project undertaken in the State.

1.1.2 The Corporation has decided to engage the services of a Legal firm for providing services in the matters Preparation of Legal Documentation, 1) Initial draft of RFP and DCA to be submitted within 3 days from start of work along with points for confirmation from Authority. 2) Finalised draft of RFP and DCA to be submitted within 5 days after receipt of confirmation from Authority. APADCL has decided to appoint a legal consultant to provide legal services to the Corporation.

1.1.3 Andhra Pradesh Airports Development Corporation Ltd., (APADCL) which is a Government Corporation, under the control of Infrastructure & Investment Department, Government of Andhra Pradesh.

1.1.4 Accordingly, APADCL has undertaken this assignment for “Selection of Legal for Providing Comprehensive Legal Services for Andhra Pradesh Airports Development Corporation Limited (APADCL)”.

1.2 Request for Quotation

1.2.1 The Authority invites Proposals from interested **Legal Firms** in the form of sealed envelopes containing Proposals forms (the “**Proposal**”) for the Selection of Legal Firm for providing Comprehensive Legal Services for Andhra Pradesh Airports Development Corporation Ltd., (APADCL).

1.3 Validity of the Applications

1.3.1 The Proposal shall be valid for a period of not less than **90 (Ninety)** days from the Proposal Due Date (the “**PDD**”).

2 OBJECTIVE

- 2.1 Objective of the assignment is to provide legal consulting services to APADCL for the following:
- (a) Review of RFP as per legal terminology
 - (b) Review of Concession Agreement as per legal terminology
 - (c) Recovery matters
- 2.2 The Legal Firms is expected to work in tandem with APADCL. The Firm shall work in close coordination with the offices of APADCL and fulfill the objectives of the Services.
- a) APADCL (the “Authority”)
 - b) Other Authorities/Consultants as directed by the Authority

3 INSTRUCTIONS TO APPLICANTS

- 3.1 Detailed description of the objectives, scope of services and other requirements relating to this Firm are specified in this RFQ. In case an Applicant possesses the requisite experience and capabilities required for undertaking the Services, it may participate in the Selection Process individually (the “**Sole Firm**”) in response to this invitation. The term Applicant (the “**Applicant**”) means the Sole Firm. The manner in which the Proposal is required to be submitted, evaluated and accepted is explained in this RFQ. The Applicants are hereby invited to submit their Request for Quotation (RFQ) for providing legal consulting services.
- 3.2 APADCL is not bound to accept any of the proposals submitted. APADCL may reject any and / or all the proposals without assigning any reasons thereof.
- 3.3 The Legal Firms (the “Applicant”) are hereby invited to submit their Request for Quotation (RFQ) for providing legal services.
- 3.4 Please note that the expenditure incurred towards cost of preparing the proposal is not reimbursable.
- 3.5 Applicants are advised to submit their proposal in the appropriate formats specified in this document.

4 SCOPE OF SERVICES

- i. Review and revision of the Request for Proposal and related schedules from a legal and contractual perspective, including assessment of the project structure, eligibility criteria, selection methodology and bid conditions.
- ii. Review and revision of the Draft Concession Agreement and related schedules from a legal and contractual perspective, including provisions relating to project term, performance obligations, revenue arrangements, risk allocation, step-in rights, termination, compensation and dispute resolution.
- iii. Advising on legal, contractual and risk related aspects under the RFP and draft Concession Agreement, wherever required to ensure that the bid documents are aligned with the project requirements including regulatory compliance and applicable statutory frameworks.

5 PERIOD OF CONSULTANCY

The tenure of the engagement is expected to be for **completion of the assignment within 15 days from** the date of Engagement. However, the Agreement period may be extended based on mutual agreement between the Authority and the firm depending upon the requirement of the Authority.

- Initial draft of RFP and DCA to be submitted within 3 days from start of work along with points for confirmation from Authority.
- Finalised draft of RFP and DCA to be submitted within 5 days after receipt of confirmation from Authority.

6 ADDITIONAL SERVICES

Based on the requirement of any further legal services by the Authority with respect to the Project beyond Scope of Services as per Clause 4 of this RFQ, the terms and conditions of Payment for such additional Services shall be finalized based on negotiation between the Authority and the Consultant.

7 REPORTING

The Firm shall work in the offices of the Authority. A designated Official of the Authority will be responsible for the overall coordination. Regular communication with the Authority is required in addition to all key communications.

8 MINIMUM ELIGIBILITY CRITERIA

The Applicant should have provided legal advisory/services in relation to Public-Private Partnership (PPP) projects, including scrutiny, review, and vetting of Request for Proposal (RFP) documents and Concession Agreements. Preferably in the airport sector.

9 SUBMISSION OF PROPOSAL

- 9.1 The minimum eligibility & financial proposals are to be submitted in two separate sealed envelopes containing minimum eligibility & financial quotation. Submission of Application(s) in hard copy in response to this RFQ through registered post/speed post/courier or hand delivered, shall be addressed to:

9.2 The Applicants are advised in their own interest to ensure that completed Application(s) reaches the office of Transaction Advisor at the address mentioned well before the date stipulated in the document. Applications submitted through Speed post/ Registered Post / Courier / Hand delivered will be accepted. Applications submitted through Telex / Telegraphic/Fax /e-mail will not be considered and summarily rejected.

9.2.1 The Proposal shall be sealed in an envelope which shall bear the address of the Authority, RFQ Notice number, Firm name as indicated in RFQ document. The envelope shall bear on top, the following text:

9.3 “Do not open, except in presence of the Authorized Person of the Authority”

If the envelope is not sealed and marked as instructed above, the Transaction Advisor assumes no responsibility for the misplacement or premature opening of the contents of the Proposal submitted and consequent losses, if any, suffered by the Applicant.

9.4 Applications received after the date and time stipulated in this RFQ will not be considered and shall be summarily rejected. Any Application received after the closing time for submission of Applications shall be returned unopened. The Transaction Advisor shall not be responsible for delayed receipt of Applications.

9.5 In case, the Application due date is an unscheduled holiday, the proposal has to be submitted latest by the next working day. The time and venue of submission will remain unchanged. A receipt thereof should be obtained from the person specified therein.

9.6 Application from unqualified firms and also incomplete/time barred applications will not be accepted.

10 EVALUATION OF PROPOSAL

- 10.1 The Authority shall open the Proposals at 1600 hours on the PDD, at the place specified in **Clause 9.1** and in the presence of the Applicants who choose to attend.
- 10.2 In the first stage, evaluation of minimum eligibility will be carried out. In the second stage, a Financial Evaluation of the Proposal will be carried out.
- 10.3** After the evaluation is completed, the Authority shall notify (by e-mail) those Applicants whose proposals did not qualify. The selected consultant will be awarded the assignment as per **Clause 12**.
- 10.4 The Selected Consultant shall be the Applicant with the lowest financial quote.

11 CLARIFICATIONS

- 11.1 To facilitate evaluation of Proposals, the Authority may, at its sole discretion, seek clarifications from any Applicant regarding its Proposal. Such clarification(s) shall be provided within the time specified by the Authority for this purpose. Any request for clarification(s) and all clarification(s) in response thereto shall be in writing (through e-mail).
- 11.2 If an Applicant does not provide clarifications sought above within the specified time, its Proposal shall be liable to be rejected. In case the Proposal is not rejected, the Authority may proceed to evaluate the Proposal by construing the particulars requiring clarification to the best of its understanding, and the Applicant shall be barred from subsequently questioning such interpretation of the Authority

12 AWARD OF ASSIGNMENT

- 12.1 The selected Legal Firm shall be the Applicant with the **lowest financial quote**. After selection, a Letter of Intent (the “LOI”) specifying terms & conditions shall be issued, in duplicate, by the Authority to the Firm and the Firm shall within **3 (Three) days** of the receipt of the LOI, sign and return the duplicate copy of the LoI in acknowledgement thereof. In the event the duplicate copy of the LoI duly signed by the Selected Consultant is not received by the stipulated date, the Authority may, unless it consents to extension of time for submission thereof, consider the next highest-ranking Applicant.
- 12.2 The Firm shall pay all taxes which they are liable to pay to State Govt. and Government of India or other authorities under any law for the time being in force.
- 12.3 **Income Tax:** Income Tax and surcharge as applicable will be deducted at source by APADCL in accordance with Income Tax Act at the rate applicable from time to time and in accordance with instruction issued by INCOME TAX Authorities on this behalf from time to time. The Consultant shall furnish the **PAN details** or a copy of Income Tax exemption certificate if any.
- 12.4 The Firm are requested to provide the financial quote as per format prescribed in **Annexure II, Form-2** for the scope of services mentioned herein, and in reference to Clause 4: Scope of Services.

13 COMMENCEMENT OF ASSIGNMENT

- 13.1 The Consultant shall commence the Services immediately after issuing of the LoI or such other date as may be mutually agreed. If the Consultant fails to either sign the LoI as specified or commence the assignment as specified herein, the Authority may invite the second ranked Applicant for negotiations.

However, Applicants from countries that have signed the Hague Legislation Convention 1961 need not get their Power of Attorney legalized by the Indian Embassy if it carries a conforming Appostille certificate.
